# Program to Program - Guaranteed Transfer Agreement between

# Business Administration Associate in Science Degree from the County College of Morris and the Bachelor of Science, Business Administration with a Major in Finance at Rider University

In the interest of providing the County College of Morris students with improved opportunities to excel in higher education, Rider University (Rider) and the County College of Morris (CCM) agree to create a Program to Program Guaranteed Transfer Agreement between the Business Administration, Associate in Science Program at CCM and the Bachelor of Science in Business Administration with a Major in Finance at Rider University.

Rider University will guarantee transfer admission, the waiver of application fee; acceptance
of all credits earned with a grade of C or better that count toward the Associate degree in
the Business Administration Program and meet Rider University equivalents; and full junior
status to all graduates in good standing of the Business Administration Associate in Science
Degree at the County College of Morris.

Rider University admission will be granted to students who have fulfilled the following criteria:

- A. Declared their participation in this program while enrolled at CCM by completing the Intent to Enroll Form. Students are encouraged to submit their application to the program before they have completed 30 credits at CCM in order to maximize the efficiency of their transfer to Rider University. Rider further agrees that we will accept the County College of Morris student up to 45 credits; but prior to completion of the last semester at CCM.
- Followed the appropriate transfer program of prescribed selections for Rider while at CCM, listed in the Business Administration with a Major in Finance Program to Program – Transfer Advising Guide.
- C. Graduated with their Associate degree at CCM.
- D. Earned a cumulative grade point average of at least a 2.50.
- E. Applied for transfer admission by the normal Rider transfer application deadline.
- 2. This agreement between the County College of Morris and Rider goes into effect immediately upon receipt of the signatures of each institution.
- 3. This agreement shall be subject to review and renewal every five years.





- 4. The County College of Morris will provide its students with full information about the Program to Program - Guaranteed Transfer Admission Program that falls under the overall Guaranteed Transfer Agreement with Rider and CCM. Students under this Program to Program Agreement will be eligible for the benefits outlined in the Rider-CCM overall Guaranteed Transfer Agreement.
- 5. Students who declare their intent to participate will work directly with CCM counseling and advising staff to obtain assistance with course selections which fulfill Rider's requirements.
- 6. CCM will provide Rider with the names and contact information of students who have enrolled in the Program to Program Guaranteed Transfer Agreement Program and Rider will establish communication with the participating students. Students will provide this information and permission to share information when they complete the CCM-Rider Guaranteed Transfer Admission Intent to Enroll Form.
- 7. The regular process for transfer admission to Rider will remain for CCM students who do not participate in this program, as well as for program participants who do not fulfill the requirements listed in Article 1 of this document.
- 8. Rider University is committed to making our educational opportunities as affordable as possible. With scholarship and financial aid, transfer students often find Rider's private education is comparable to attending a public college or university. The CCM transfer student, who holds a GPA of 2.50 to 4.00 on college-level work, is eligible upon the submission of a full-time student application, for consideration for transfer scholarship and grants. In addition, for those students of Phi Theta Kappa (PTK) at the County College of Morris, the student may be eligible to receive an annual renewable scholarship. - 9. CCM students, following completion of the CCM-Rider Guaranteed Transfer Admission Intent to Enroll Form, have the option to take a course at Rider that counts toward the Rider degree at no charge. The course may be taken following completion of 30 college-level credits at CCM and prior to the time period before their matriculation with Rider University. The designated course (s) requires a grade of "C" or better and allows the CCM student to experience first-hand the academic environment at Rider. The course credit options are: FIN-220-Introduction to Finance (3) or MGT-336-Career Management (3).

To Students have a number of options to satisfy this requirement; courses will be evaluated on an individual basis.

For transfer credit County College of Morris students must have a grade of "C" or higher in all courses. (No transfer credit will be accepted for any course with a grade of "C-" or below.)

County College of Morris students interested in the College of Continuing Studies (CCS) at Rider should contact that division directly.

Rider, College of Business Administration does not currently have a foreign language requirement.

β-If CCM students take MAT-124-Statistics or MAT-130-Probability & Statistics it transfers as MSD-200-Statistical Methods I. If MAT-126-Advanced Statistics is taken in the second semester, it transfers to Rider as MSD-201-Statistics II. Both then waive the need to take MSD-105-Quantatative Methods for Business at Rider.
